# **PREAMBLE**

data.aide-developpement.gouv.fr is the website for the release of open public data (open data) on official development assistance. It depends on the French Ministry of Economy, Finance and Industrial and Digital Sovereignty (MEFSIN) and the French Ministry of Europe and Foreign Affairs (MEAE), which are using a service in SaaS mode, developed and maintained by the OpenDataSoft company.

This service enables producers of official development assistance to publish their data openly. It allows users of the data to explore, visualize and reuse them.
